WHITE HOUSE LISTENING SESSION ON OCEAN CLIMATE ACTION PLAN

The Ocean Policy Committee (OPC) is the federal government's primary interagency coordinating body for ocean research, technology, and marine resource management. The OPC, which is co-chaired by the White House Office of Science and Technology Policy and the Council on Environmental Quality, is developing an Ocean Climate Action Plan, which will promote ocean activities that can provide overall climate solutions and will focus on topics like conservation, green shipping, renewable energy such as offshore wind, and marine carbon dioxide removal. The OPC is interested in hearing from Tribes and Indigenous Peoples on this initiative, especially in the context of example solutions, opportunities to improve interagency coordination on this topic, and opportunities to improve Tribal coordination with the federal government on these efforts.
